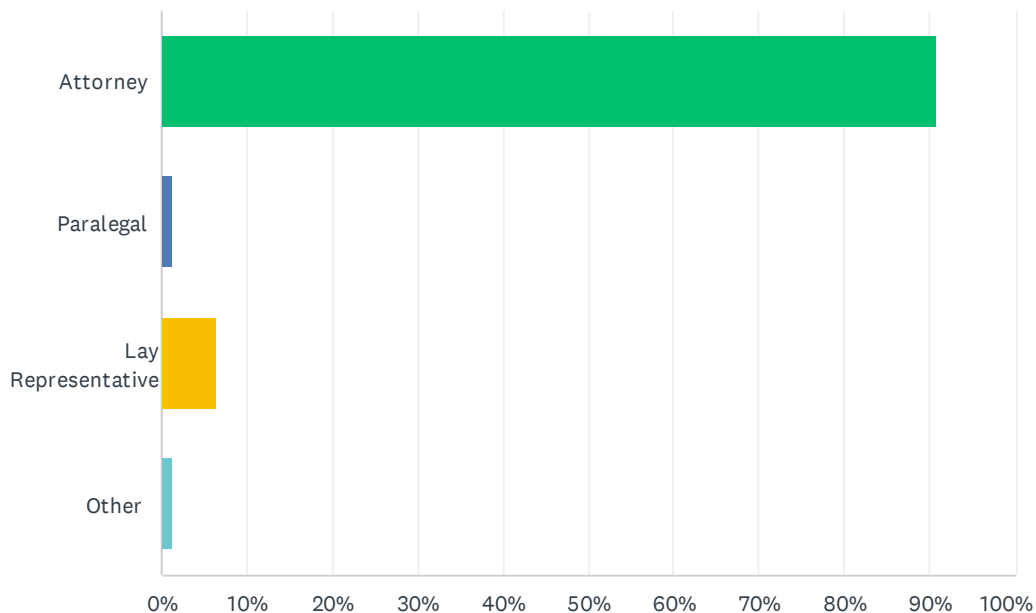

Q177 What best describes your professional role before the Board of Industrial Insurance Appeals?

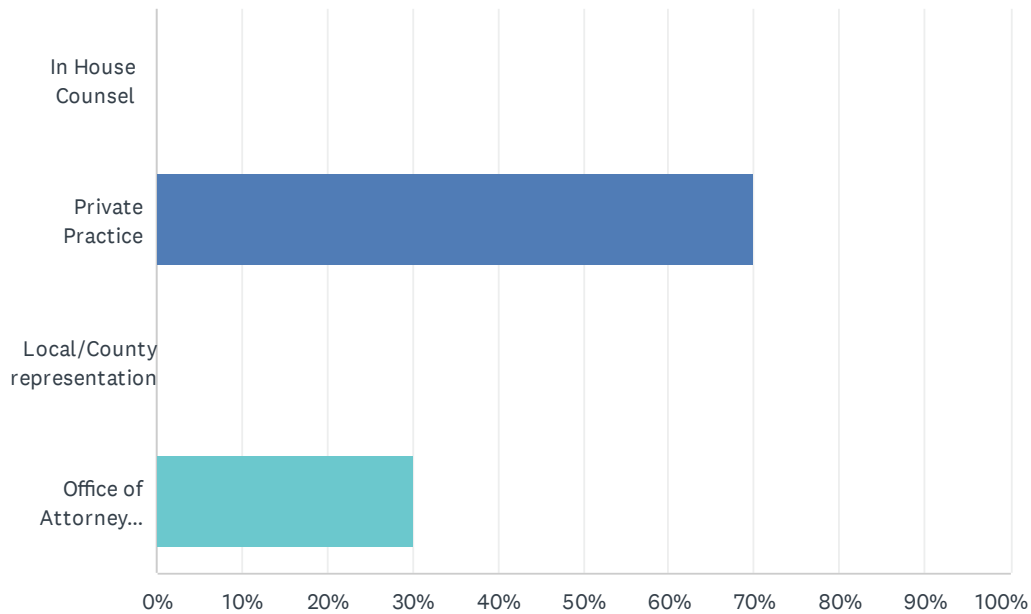

Q178 If you are an attorney, what is the nature of your practice?

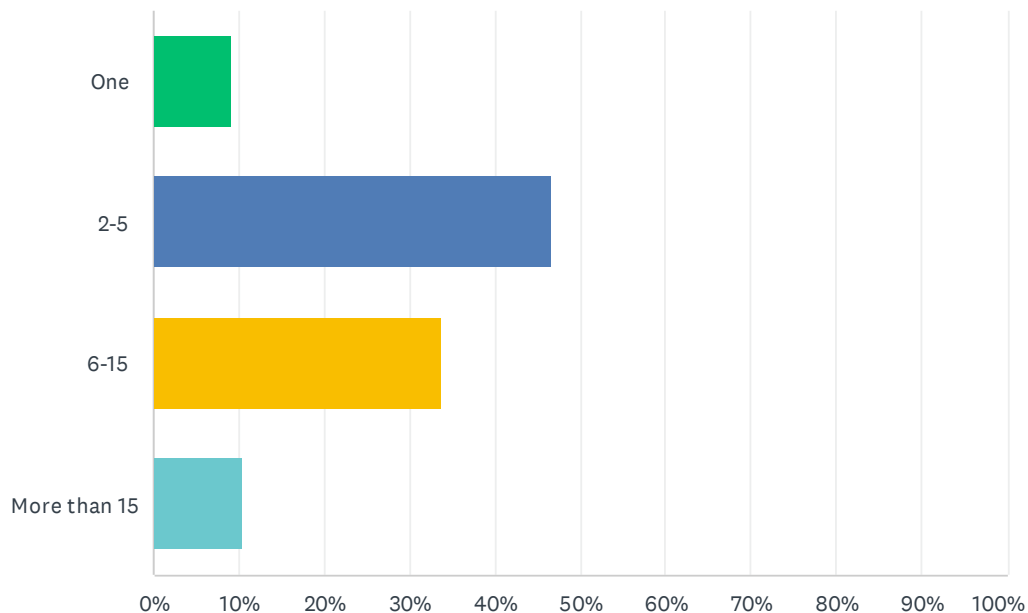
